STAFF REPORT – Jessica Stewart: We appreciate you!

 Demographics requested by UUA, as well as pronouns to be included in survey of the congregation, in coordination with directory update. We will include disability and accommodation needs. Jessica will create a Google Form to survey the congregation.

## COVID CARE TEAM UPDATE: Poll results, Contract Tracing

- Barbara: out of 15 people she talked to, 13 people said yes come back, enforce masking and distancing, don't mind having kids in service. 2 people suggested vaccination proof, though they admitted that would be difficult to do.
- Zoom poll: 90% want masks, 70% want distancing, 60% comfortable with children in service, 40% want proof of vax, 20% comfortable with no restrictions, 10% not comfortable returning to in-person.
- Janine moves that we return to in-person services, with Zoom and contact tracing, masking and social distancing enforced and children allowed in service with masks, coffee hour outdoors, positive tests must notify the church. Barb seconds, all are in favor.
- Scott and Sonja need some time to pull the tech together. They think Oct. 24 would be a good date to resume if the board sees fit.
- Do we provide child care?
- RE will continue as before.
- Coffee hour would be outside.
- Positive tests should notify the church, then we will notify those who were present at the service. Let people know that if they are vaxxed they don't need to quarantine unless they have symptoms, otherwise it is recommended that they quarantine.
